## **TERMS AND CONDITIONS**

### **New Accounts**

A State Resale Tax ID number is required to process and ship your order.  
2 trade references and a bank reference is necessary to obtain a credit account:

### **Minimum Order**

Minimum opening order \$150. Minimum reorder \$100. Orders less than \$100 will have a \$10 handling fee added.  
Minimum order quantity is 1 each, unless otherwise noted.

### **Terms**

All first orders must be prepaid by check or money order or paid by credit card. All orders under \$100 must be pre-paid by check or money order or paid by credit card.

Net 30 days from the date of invoice with approved credit. Open term accounts receive 2% discount for all credit card orders that meet required order minimums and are charged at the time of shipment. Credit card accounts do not qualify for this discount.

### **Late Charges**

Invoices not paid in terms are subject to a 11/2% per month late fee. A \$30 fee will be charged on all returned/NSF checks. All collection and attorney fees are the responsibility of customer for unpaid balances. Accounts not current will be placed on credit hold.

### **Prepayment**

Acceptable forms of prepayment are a cashier's check, money order or Visa/Mastercard. Personal or business checks are subject to delay for bank clearance.

### **Purchase Orders**

All POs must be signed by authorized buyer. Entering the buyer's name on online forms will be equal to an authorized signature.

### **COD**

C.O.D. Orders can only be shipped UPS Ground to the 48 contiguous states.

### **Delivery**

All orders will ship UPS Ground. Allow 1 to 2 weeks on open accounts. All prices are FOB Sparks, NV, prepaid and added to invoice, and subject to change without notice. If using a credit card, actual freight charges will be charged to credit card orders at the time of shipment.

Upon request, we offer next day, second day and third day deliveries at your expense. Orders requesting services other than our UPS service or using your UPS/Fed Ex number will be assessed a \$25.00 service fee. If service other than UPS Ground is requested, the order must be paid by credit card.

Calculations for freight on prepaid check orders shipped within the contiguous 48 states:

Under \$50	= 25%
\$51 - \$100	= 20%
\$101 - \$200	= 17%
\$201 - \$300	= 15%
\$301 - Over	= 12%

Calculations for freight on prepaid check orders shipped outside the contiguous 48 states:

50% of total order

### **Drop Ship Program**

Our drop ship program is very beneficial to on-line stores, retail sales as well as home parties. You can collect the orders from your customers and we will ship the order for you directly to them. This program allows you to add more items to your current collection without you having any inventory or additional cost!

### **Back Orders**

Back orders under \$50 are automatically canceled. Backorders over \$50.00 are automatically shipped as product is available unless specified by customer.

### **Claims**

All claims must be submitted for approval via fax or email within 7 days.

Damages in shipping must be reported to the courier by the customer. On UPS damage or claims, the original shipping cartons must be retained, and we should be notified for UPS pickup. Inspect the shipment immediately. Return product to original carton complete with packing materials.

Quiet Fire Studio is not responsible for credits or replacements on claims placed more than 7 days after receipt of goods.

### **Returns**

We accept returns on merchandise that is defective upon receipt if reported within 7 days of date of delivery. A return authorization number is required for all returns. Items returned without authorization will be refused.

All items must be without price markings or stickers, in original packaging and sellable condition. Freight charges must be prepaid. All returns are subject to a 20% restocking fee. Fees & freight charges are non-refundable.
